The standard vendor space has been increased from 12' x 12' to 12' x 16' while Covid-19 precautions are in place, thus we have fewer spaces. Vendors may reserve up to two spaces if applied for early, once we start announcing actual markets. If a vendor reserves more than one space, the VIA will assume the vendor wants adjoining spaces unless indicated otherwise. Perimeter spaces, those spaces reserved in the outside aisles of the field, are allowed one vehicle to remain at the space.

Due to the uncertainty over Covid-19 restrictions, we are not signing up vendors or non-profit organizations for specific markets at this time, nor are we collecting any payments right now. We hope to be able to do that later, once the covid-related restrictions are lifted. For now, we will handle things market by market. Once we receive your information on this form, we will not require it again when you apply for each market.
