Dear Neighbor,

The Commons Development Committee is excited to share with residents the results of our survey and focus group. The Committee opted to conduct a survey and focus group for neighboring landowners to gather current, detailed information on what residents would like to see on the Town Commons. We deliberately did not consider cost or funding at this point. The goal was to learn what residents wanted, if anything.

The Committee felt it is important the community had the same data as the Committee. The Committee will use this data, and information about costs, to inform the development of a comprehensive plan. The plan is likely to be multi-stage with initial steps being less costly. The Committee will share the plan with the community for feedback prior to undertaking efforts to improve the Commons.

The Committee presented data in PowerPoint slides from a Town Hall Meeting on Monday, June 25, 2018. Additionally, the Committee developed a table that summarized the data by item. We attached the slides and table to this letter, posted on the Town website. **Commented [CDC3]:** Seven people who submitted surveys did not complete this item.

**Commented [CDC4]:** Sixty-three of the people who responded to the survey live in Irvington seasonally.

**Commented [CDC5]:** Nearly sixty-nine percent of respondents live in Irvington full-time.

**Commented [CDC6]:** Thirty-one respondents have lived in Irvington less than five years.

**Commented [CDC7]:** Nearly eighteen percent of respondents have lived in Irvington between five and ten years.

**Commented [CDC8]:** Approximately seventy-five percent of respondents have children in their household less than 4 weeks a year.

**Commented [CDC9]:** NOTE: 52 people indicated they had children at least four weeks a year. Some people completing the paper version did not skip this question, which is why the response number is higher than the number who indicated they had children more than four weeks a year.

Individuals who did not circle Yes were counted as a No.

**Commented [CDC16]:** Twenty-three of the 228 people who responded to the survey indicated they would like to see baseball and softball fields on the commons.

**Commented [CDC17]:** Twenty-five people ranked a bocce ball court in their response to the survey.

**Commented [CDC18]:** Nearly fifty-three percent of the people who ranked a community center in their response ranked it in their top five.

**Commented [CDC19]:** Fifty-eight percent of the people who responded Yes or No to items (or on the electronic survey, ranked an item 5 or higher) said "yes" to a farmers' market facility.

- → 383 surveys mailed.




# Responses

  - 182 completed paper surveys (79.82%)




# Description of Respondents





Nearly 69 percent of respondents reported they live in Irvington full-time.



# Age of Children

- 13.79% younger than elementary school
- 26.44% in elementary school
- 10.34% in middle school
- 8.05% in high school
- 41.38% older than high school

Of those who reported the age of the children in their households, forty-one percent have children older than high school.

Note: 87 responses (52 indicated on the previous question they had children in their household more than 4 weeks a year).




# Use of the Current Commons


# **Data Cleaning**

- Care must be taken not to ruin it!
- Fence for boundary
- Buildings on North Commons



# Watch costs (and taxes

- Town money could be supplemented by grant or foundation money
- No reason to [do anything], refund tax money
- One needs to understand costs before saying "I want this." One needs to understand maintenance and liability. To tax the many for the wants of a few is unjust. Residents should not be forced to pay for the wants of tourists and a few families with children.
- We should be spending our funds in a way which increases both tourism and a "town" feeling to attract new residents.



# Playground

- Placement and equipment are not safe
- Would have gone more if the facility was safe and upgraded

 Incorporate steamboat theme to tie to museum and area



## New buildings/development

- Some is ok, but limited
- Irvington seems to be holding back good growth - we need to let it happen
- Add to the Museum
- Spaces/structures with more than one use like a farmers' market facility that can also be used as a private event venue and community center
- I think a Visitor Center could be accomplished by leasing existing space in town. Maybe the same for Town Hall.




## Other
